In the Terminator movie franchise, the third installment was titled Terminator

*3: Rise of the Machines* and continued the original movie's theme of how the growth of Artificial Intelligence (AI) would ultimately lead to the end of civilization, as AI would discover that it no longer had need of humans. Fortunately, as AI is still in its infancy, the stock market is pricing in only the positive aspects of the



technology. While graphic chips provider Nvidia (up 82% in Q1) has served as the poster child for Artificial Intelligence investments, many other technology companies (such as Super Micro Computer – up 255% in Q1) with some connection, or perceived connection, to AI rallied strongly in the first quarter. This led to an overall positive market sentiment throughout the period that lifted the S&P 500 and the NASDAQ 100 higher.

Ultimately, we believe the most powerful trend in AI will be the productivity enhancements experienced by many companies across a wide swath of industries. **<u>READ (or watch!) # **MCWS Client Investment Portal Updated**

Effective April 1, McKinley Carter introduced an updated version of the MCWS client portal. It sports a fresh user interface, provide additional functionality, and later this spring will be followed up with a new mobile app for easier access on your Apple or Android devices. The new portal went live at the <u>same</u> <u>website URL</u> as the current portal. Your login credentials (email address and current password) have remained the same.

### What's New in the Updated Version?

Several things! Check out some highlights below or watch our video introduction to the new portal <u>HERE</u>.

- Basic and Advanced dashboards are available to show the level of detail you want to see. You can also create your own personalized dashboard with only the information you want to see, arranged just how you like it.
- **Greater customization.** Most widgets on your dashboard will have a "3-dot" menu with additional options for displaying its information. When you click on a widget to drill down further, additional options become available. One exciting new option is custom date periods that allow you to view holdings, performance, and transactions for dates or time periods of your choosing. Also, you can now switch your portal user interface between "light" and "dark" modes for easier viewing.
- Accounts outside of MCWS management can now be linked to the portal to show a more complete picture of your net worth, including bank accounts, debts, and real estate.

### I Prefer My Current Portal...Can I Keep It?

Sure. Sometimes we already have everything arranged just the way we like it! You can contact your McKinley Carter advisor and let them know you prefer to keep your current portal version. Please be aware, though, the new client mobile app will only work with the new version of the portal.

#### New Mobile App on the Way
